

## Alex P. Part 2 The toughest fight of his life

As a young man Alex fought many battles in the boxing ring but nothing like the battle he had when after 19 years in the fellowship he drank again. Three things happened that set up him up to return to the abyss of active alcoholism. First, his sponsor died and he didn't get another, second when he moved from Campbell River to Vancouver he didn't join a home group and third, he drifted away and stopped going to meetings. It took Aex 4 years to get back into the fellowship and sober up. He was coaxed into being the door greeter so he wasn't able to isolate, he moved to setting up the meeting and making coffee for a group of over 100 attendees. After the meeting he would have up to 30 members come to his home till the wee hours of the morning. His wife, Evelyn, who was so happy to witness Alex's recovery she would stay up making coffee and listen to the stories. Very much like Anne Wilson, the wife of our Cofounder Doctor Bob. He moved to Merritt and got involved in service above the meeting level

as that districts an intgroup representative. Then back in North Vancouver he went from Alternate General Service Representative and then General Service Rep of his group. Then he became the District Committee Member D.C.M. for the North Vancouver district.

He also ended up chairing the North Shore Roundup which is now one of the largest Alcoholics Anonymous Rally's in Western Canada.

In Area 79 B.C. Yukon he volunteered as the Grass Roots Chair and then onto the treasurers position. He moved onto the Alternate delegate position in 93 to 94 and then the Area Delegate in 95 to 96. He was sent to the San Diego International Convention also chairing the B.C. Yukon Convention in 1997. He worked in so many round

ups and workshops gratitude constant continuously to many to list.


Then his travel in service intensified in 1999 after becoming Trustee at large Canada which automatically positioned him as the World Service Delegate. He went to New York a minimum of 4 times a year for Quarterly meetings and the General Service Conference once a year. Their mission was to carry the successes of Alcoholics Anonymous to the world.

Alex as our World Service Delegate attended Redela Zonal meetings (The meetings of the Americas) in El Salvador and Columbia. He also went to the countries of Panama, Peru and Brazil and has great stories to tell of those adventures. He went to Spain, Portugal and Lithuania which struck him so much because he said he was impressed how in a few short years A.A. grew from a very few members to over 100 groups). He also travelled to England, Japan, Hong Kong and Thailand.

## A.A. in correctional facilities

There are approximately 1,487 A.A. groups meeting in correctional facilities throughout Canada and the United States. Each has a local arrangement between the administrators of the prison and nearby A.A. groups.

A frequent question is why inmates have any need of A.A. while they are incarcerated. The answer is that the A.A. program is far more than staying away from alcohol. A.A. has been called a way of life, and its success for groups that meet while in custody shows that this program can help the alcoholic inmate live a sober and contented life, both while in custody and after release.

Many inmates were sentenced for crimes in which alcohol abuse was an important factor. This percentage appears to be somewhat higher among inmates in facilities for young offenders.

Corrections professionals often find many benefits for those inmates who attend A.A. meetings, and feel that an inmate's chance of making it on the outside is improved by participation in the A.A. program

# Q and A for Alex: What bothers you most about A.A.

So many people who come to the fellowship and just sit in a chair, putting nothing in but expecting something out of it. They do not understand that without getting involved in service to each other, the group and above the group level A.A. will die. They don't understand that the structure of general service which includes the GSR, the DCM the members of the Area committee and the G.S.O. in New York is so important to our survival.

If you started up a worldwide business with no organization or no one in authority, no dues or fees and everyone works on a volunteer basis.

Business leaders would say impossible but that is just the way A.A. works. Our fellowship works just the opposite of how every other business structure operates. Alcoholics Anonymous has been successful in helping those suffering alcoholics for over 80 years. Still many people want to modernize the program, rewrite the Big Book along with other changes.

# Alex what do you like best about A.A.?

It works if you work it. A.A. saved my life and allowed me to lead a life of value. It works the way it is written. Everyone has and can voice an opinion. The minority voice is very important. We have the opportunity to disagree without being disagree - able. We can voice our opinion through a motion and vote on it. Our ultimate authority is God through our group conscience.

On a personal note, Alex and his wife Evelyn lost two daughters and a son over the past decade to illness. And through those tragedies Alex says. "Taking a drink was never an option.

Alex now has 42 years of continuous sobriety since he got back into A.A. after his relapse. He and Evelyn still live in Abbotsford hosting many friends in their home and still carrying the message.
